

#### Stuff that Matters (a.k.a. Public Policy)

Many people stop listening as soon as they hear the words public policy, thinking, "I don't know anything about that stuff." I am asking you to PLEASE KEEP READING! It should take less than five minutes of your time, and then you can decide whether or not this "public policy stuff" is something you should follow.

Arkansas Stuff – Our general assembly/legislators only meet for a few weeks (Jan – April) in odd-numbered years (even years only deal with budgets). What they do or don't do in these weeks is important! We will have to live with the outcome for a minimum of two years before we could hope to change it. That small detail helps hold my attention until spring  $\Box$ 

Kids Count Day -- More than half of our current legislators have served in only one legislative session (or less!). Therefore, members of AECA, the Invest Early Coalition, and Kids Count were at the Capitol on February 9 to educate new and returning legislators (on the effectiveness of the Arkansas Better Chance Program (ABC). There are still about \*11,299 eligible 3 and 4 year old children who are not able to participate in ABC or Head Start. While at the Capitol, we explained to legislators that there is no more efficient tool in closing the achievement gap than high quality early education. We know the economy makes it challenging to balance the state budget but if they happen to find some extra money somewhere  $\square \dots$  we know a GREAT way to use it. We also found opportunities to say thank you for the past support for ABC and early education.

Our current concern – You may have heard that legislators are talking about tax cuts. But you may not have heard how those decisions will affect you, especially if you provide ABC programs for Arkansas children. State revenues are tight. There is just enough money coming in to cover the services on which we all rely: education, health, roads and many more. Tax cuts would mean less money to put police officers on the street and support teachers in classrooms. Our lawmakers benefited from many of these services as children. Now it's our job to remind them that children today and tomorrow need the same services. Services that you care most about, like Arkansas Better Chance, aren't directly threatened. But if we sit by while state revenue is chipped away then in it could soon be.

Federal Stuff – Wow, where do we start? Let's start with vouchers: We NEED MORE! Currently in Arkansas there are more than 12,000 children on the waiting list. The good news – As of February 14, President Obama put \$1.3 billion additional dollars into the Child Care Development Fund (which funds vouchers for states) in his budget and \$866 million additional dollars for Head Start and Early Head Start. This is exciting, but the President's budget is really only a recommendation to Congress. You may be aware that many members of Congress believe cuts are needed; keeping additional money will be an uphill battle, to say the least.

Here's what you can do as an AECA member – You should have received an email inviting you to the Invest Early E-alerts. If you did not, PLEASE GO TO http://www.aradvocates.org/e-newsletter-sign-up/ and enter your contact information and click the Invest Early box (plus any other topics of interest). The Invest Early Coalition will keep you posted on state legislation that affects early education and let us know what we can do. The Invest Early steering committee voted to pass along alerts from Arkansas Advocates for Children and Families that relate to the Child Care Development Fund.

Our voices matter so, I urge you to use them. In the near future we're going to need every voice we can get from every corner of the state to speak up for children. The children can't speak for themselves, and this stuff will matter to them and to their families.
